TRADITIONAL BLACK AMAZON COMMUNITY FIGHTS FOR RECOGNITION OF LAND RIGHTS

The community of Boa Vista, Para, is a "quilombo," comprised of descendants of escaped slaves who live along the Trombetas River in the northern Amazon region of Brazil. They now are close to achieving legalization of their traditional land rights. If successful, Boa Vista would be the first community achieving such recognition since the legal opportunity was presented in the new Brazilian constitution.

This request is being made on behalf of ARQMO, the Association of Communities Descended from Quilombos in Oriximina Municipality, which represents 21 quilombo communities, with a total population of 6,500 people along the Trombetas, Cumina, Erepecuru and Acapu rivers.

Hearly 200 years ago, their ancestors fled from cattle ranches and cacao plantations in the Amazon and climbed the Trombetas River. They went further and further into the Amazon, until they settled in areas which, at that time, were 45 days by boat from the nearest settlements.

The legal demarcation of the area is considered urgent, given pressures on the community from a multinational mining operation, Mineracao Rio do Horte (Alcoa, Reynolds, Norsk Hydro), nearby.

Despite the presence of aluminum processing facilities in Porto Trombetas, Boa Vista has no electricity.

Now, plans are being carried out for construction of a hydroelectric dam on the Trombetas River. Boa Vista has already lost many of its AfroAmazoniancultural traditions, but the demarcation would be an important precedent for dozens of other quilombos throughout Brazil. A campaign is now underway to achieve these demarcations in observation of the three hundradth anniversary of Zumbi de Palmares, who led slave uprisings in colonial Brazil.

The legal process is now before the Institute for Colonization and Agrarian Reform (INCRA), which is considering Boa Vista's petition for demarcation of a 798 hectare area for 100 families.
