EXPRESS MY CONCERN REGARDING THE DELAY IN IMPLEMENTATION OF
THE SPECIAL PROJECT FOR THE PROTECTION OF THE AMERINDIAN
POPULATIONS IN THE AREA OF THE POLONOROESTE PROGRAM AS
AGREED IN SECTION 4.05 OF LOAN 2060-BR. (PRIMO) IT IS MY
UNDERSTANDING THAT LITTLE PROGRESS HAS BEEN MADE IN
DEMARCATING AMERINDIAN RESERVES, PARTICULARLY THOSE OF THE
NANBIKWARA GROUPS IN MATO GROSSO WHICH WERE SPECIFIED IN
PORTARIAS NOS. 1125/D, 1126/D, AND 1127/D ISSUED DECEMBER 2,
1981. I UNDERSTAND THAT FUNAI PREPARED A REPORT IN MAY 1982
WHICH CONFIRMED THE ADEQUACY OF THOSE RESERVES AND ESTIMATED

THE COSTS OF INDEMNIZATION TO LANDHOLDERS WHO WOULD BE AFFECTED BY THE DEMARCATION OF THOSE RESERVE BOUNDARIES. SINCE THEN, NO ADDITIONAL ACTION HAS BEEN TAKEN TO BEGIN INDEMNIZATION AND PHYSICAL DEMARCATION OF THESE RESERVES IN THE FIELD. (SECUNDO) I ALSO UNDERSTAND THAT FUNAI HAS NOT YET BEEN ALLOWED TO HIRE THE ADDITIONAL STAFF REQUIRED FOR 1982 AND 1983 WHO ARE CRUCIAL TO THE EXECUTION OF THE PROJECT. PHYSICAL FACILITIES ALREADY BUILT TO PROVIDE SERVICES TO AMERINDIAN POPULATIONS ARE THUS OF LITTLE USE TO DATE. UNLESS STAFF AND ADEQUATE OPERATING FUNDS ARE ALLOCATED, THE PROJECT CANNOT REACH ITS OBJECTIVE TO PROTECT AND ASSIST THE AMERINDIANS. (TERCO) AS YOU ARE AWARE, OTHER COMPONENTS OF THE POLONOROESTE PROGRAM HAVE BEEN PROCEEDING ON SCHEDULE. CONSTRUCTION OF THE HIGHWAY HAS BEEN FACILITATED BY LOW RAINFALL THIS PAST YEAR, AND THE ASSOCIATED AGRICULTURAL DEVELOPMENT COMPONENTS HAVE BEEN PROCEEDING SMOOTHLY IN RONDONIA AND MATO GROSSO. BECAUSE OF THIS, I AM SURE YOU WILL AGREE THAT FURTHER DELAY IN THE FINAL DEMARCATION OF THESE RESERVES AND AUTHORIZATION FOR ADDITIONAL REQUIRED STAFF FOR FUNAI WOULD BE DETRIMENTAL
